1. In this form and these notes, "he" means "he" or "she" as far as the context permits.
2. In accordance with Chapter 4 of the Guidelines on Election-related Activities in respect of the Village Representative Elections, the candidate should, **within 1 working day** after publication of an election advertisement, post an electronic copy of the relevant information/document, including permission or consent, onto the Central Platform or Candidate's Platform or deposit a hard copy with the Returning Officer for public inspection.
3. Candidates should cover all the identity document number(s) in the form before uploading this form onto the Central Platform or Candidate's Platform.
4. According to Chapter 14 of the Guidelines on Election-related Activities in respect of the Village Representative Elections, if a written consent is given by a person in his personal capacity, no mention should be made of any office title which he may have, in the candidate's election advertisements and campaign activities.
5. According to Chapter 14 of the Guidelines on Election-related Activities in respect of the Village Representative Elections, in the case where an office-bearer of an organization wishes to use his office title to support a candidate, he should be careful not to give the impression that it represents the support of the whole organization except where a decision has been so taken by the governing body of the organization or by a resolution of the members of that organization passed at a general meeting. Items 2 & 3 of this consent form must be completed if the name of the organization concerned is specifically mentioned in the office bearer's title or the relevant election advertisement is posted in the organization or building in which he is serving.
6. According to section 27(5) of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554), a consent of support in writing by an organization must be approved by the governing body of the organization or by a resolution of the members of the organization passed at a general meeting.
7. In the case where a Mutual Aid Committee wishes to support a candidate in the name of the Mutual Aid Committee, the written consent should be taken in a general meeting convened in accordance with the Model Rules for the Mutual Aid Committee, and signed by the incumbent Chairman of the MAC.
8. According to section 2(1) of the Village Representative Election Ordinance (Cap. 576), "Identity document" means—
 - (a) an identity card; or
 - (b) any other document issued to a person that is acceptable to the Electoral Registration Officer as proof of the person's identity.
9. A witness can be any person aged 18 years or over and in possession of an identity document. Please refer to Note 8 above for the meaning of identity document.

11. Please note the following with regard to the personal data supplied in connection with this consent –
 - (a) **Purpose of Collection**
The personal data and other related information provided in connection with this consent will be used by the Home Affairs Department and the Returning Officer for election-related purposes.
 - (b) **Transfer of Information**
The consent form will be made available for public inspection. All identity document numbers in the consent will be covered before display. The information in this consent may also be provided to other authorized departments/agencies for election-related purposes.

(c) **Access to Personal Data**

A person has the right to request access to and correction of the personal data which he supplied in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).

(d) **Personal Data Protection Principle**

The candidate is reminded to observe the Data Protection Principles in Schedule 1 to the Personal Data (Privacy) Ordinance (Cap. 486) in collecting personal data of a third person in completing the relevant form, in particular Principle 4 concerning the requirement to take all practicable steps to ensure that personal data are protected against unauthorized or accidental access and processing.

(e) **Enquiry**
