- 2. In accordance with Chapter 4 of the Guidelines on Election-related Activities in respect of the Village Representative Elections, the candidate should, within 1 working day after publication of an election advertisement, post an electronic copy of the relevant information/document, including permission or consent, onto the Central Platform or Candidate's Platform or deposit a hard copy with the Returning Officer for public inspection.
- 3. Candidates should cover all the identity document number(s) in the form before uploading this form onto the Central Platform or Candidate's Platform.
- 4. According to Chapter 14 of the Guidelines on Election-related Activities in respect of the Village Representative Elections, if a written consent is given by a person in his personal capacity, no mention should be made of any office title which he may have, in the candidate's election advertisements and campaign activities.
- 5. According to Chapter 14 of the Guidelines on Election-related Activities in respect of the Village Representative Elections, in the case where an office-bearer of an organization wishes to use his office title to support a candidate, he should be careful not to give the impression that it represents the support of the whole organization except where a decision has been so taken by the governing body of the organization or by a resolution of the members of that organization passed at a general meeting. (d) Personal Data Protection Principle

The candidate is reminded to observe the Data Protection Principles in Schedule 1 to the Personal Data (Privacy) Ordinance (Cap. 486) in collecting personal data of a third person in completing the relevant form, in particular Principle 4 concerning the requirement to take all practicable steps to ensure that personal data are protected against unauthorized or accidental access and processing.
