# **Explanatory Notes on Completion of Advance Return and Declaration of Election Donations**

- 1. 在這申報書及聲明書及說明中,在文意許可的情況下, "他" 是指 "他" 或 "她"。 In this return and declaration and these notes, "he" means "he" or "she" as far as the context permits.
- 2. 在填寫此申報書及聲明書前,請細心閱讀《選舉(舞弊及非法行為)條例》(第 554 章)。
  Please read the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554) carefully before completing this return and declaration.
- 3. 請用中文或英文填寫此申報書及聲明書,並將填妥的申報書及聲明書交付予所屬鄉村的選舉主任。

- (b) any goods given to or in respect of the candidate for the purpose of promoting the election of the candidate or of prejudicing the election of another candidate or other candidates, and includes any goods given incidental to the provision of voluntary service;
- (c) any service provided to or in respect of the candidate for the purpose of promoting the election of the candidate or of prejudicing the election of another candidate or other candidates, but does not include voluntary service.
