Notes on Completion of Notice of Withdrawal of Candidature

- 1. 在這通知書及說明中,在文意許可的情況下,"他"是指"他"或"她"。 In this notice and these notes, "he" means "he" or "she" as far as the context permits.
- 2. 獲提名而 <u>欲退出選舉的候選人,須填寫本通知書。通知書須由候選人於見證人在場下簽署</u>。任何年滿 18 歲並持有身分 證明文件的人士,均可擔任見證人。根據《村代表選舉條例》(第 576 章)第 2(1)條,"身分證明文件" (identity document)指 –

This notice should be used by <u>a nominated candidate who wishes to withdraw his candidature</u>. It should be signed by the candidate <u>in the presence of a witness</u> who can be any person aged 18 years or over and in possession of an identity document. According to section 2(1) of the Village Representative Election Ordinance (Cap. 576), "identity document" (身分證明文件) means—

- (a) 身分證;或 an identity card; or
- (b) 向某人發出而可獲選舉登記主任接受為該人的身分證明的任何其他文件。 any other document issued to a person that is acceptable to the Electoral Registration Officer as proof of the person's identity.
