- 2. In accordance with Chapter 4 of the Guidelines on Election-related Activities in respect of the Village Representative Elections, the candidate should, **within 1 working day** after publication of an election advertisement, post an electronic copy of the relevant information/document, including permission or consent, onto the Central Platform or Candidate's Platform or deposit a hard copy with the Returning Officer for public inspection.
- 3. Candidates should cover all the identity document number(s) in the form before uploading this form onto the Central Platform or Candidate's Platform.
- 4. According to Chapter 14 of the Guidelines on Election-related Activities in respect of the Village Representative Elections, if a written consent is given by a person in his personal capacity, no mention should be made of any office title which he may have, in the candidate's election advertisements and campaign activities.
- 5. According to Chapter 14 of the Guidelines on Election-related Activities in respect of the Village Representative Elections, in the case where an office-bearer of an organization wishes to use his office title to support a candidate, he should be careful not to give the impression that it represents the support of the whole organization except where a decision has been so taken by the governing body of the organization or by a resolution of the members of that organization passed at a general meeting. Items 2 & 3 of this consent form must be completed if the name of the organization concerned is specifically mentioned in the office bearer's title or the relevant election advertisement is posted in the organization or building in which he is serving.
- 6. According to section 27(5) of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554), a consent of support in writing by an organization must be approved by the governing body of the organization or by a resolution of the members of the organization passed at a general meeting.
- 7. In the case where a Mutual Aid Committee wishes to support a candidate in the name of the Mutual Aid Committee, the written consent should be taken in a general meeting convened in accordance with the Model Rules for the Mutual Aid Committee, and signed by the incumbent Chairman of the MAC.
- 8. According to section 2(1) of the Village Representative Election Ordinance (Cap. 576), "Identity document" means-

 - (b) any other document issued to a person that is acceptable to the Electoral Registration Officer as proof of the person's identity.
