Notes on Completion of Nomination Form for the Rural By-election (Indigenous Inhabitant Representative)

以下說明只供參考。有關提名事宜的法例,請參閱《鄉郊代表選舉條例》(第 576 章)、《選舉程序(鄉郊代表選舉)規例》(第 541 章,附屬法例 L)、《選舉(舞弊及非法行為)條例》(第 554 章)及其他有關法例。

The Notes below are for reference only. For legislation concerning nomination matters, please refer to the Rural Representative Election Ordinance (Cap. 576), the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541 sub. leg. L), the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554) and other relevant legislation.

- 1. 每份提名表格只能用以提名一位候選人。
 A separate nomination form must be used for each candidate.
- 2. 如候選人選擇公開其職業及任職公司/機構名稱的資料,他/她可在提名表格內申明。
 If a candidate so wishes, he/she can state his/her occupation and name of company/ organisation on the nomination form.
- 3. 是否提供聯絡資料予傳媒使用屬自願性質。該等資料會提供予傳媒以便他們/她們直接聯絡有關候選人。
 - The supply of contact information for the media is optional. The information will be provided to the media to facilitate them to contact the candidate concerned directly.
- 4. 每份提名表格須由最少 5 位提名人親自簽署表示同意提名。所有提名人必須已登記為有關原 居鄉村/共有代表鄉村的選民。為避免因有提名人不符合資格而令提名失效,提名表格可由多 於 5 位提名人簽署。如超過 10 位提名人,必須使用提名表格第 3 頁的補充頁,而第 3 頁的每 張補充頁均須填上由 "3(1)"開始的順序頁碼。在遞交提名表格時,表格的每一頁(包括第 3 頁的所有補充頁)必須一併交予選舉主任。候選人應查證提名人的資格。倘若基於任何原因, 某位提名人被發現不符合資格,他/她的提名將不予理會。候選人亦須提醒每位提名人應填寫 在其身分證明文件(指提名人記錄在正式選民登記冊內的資料所依據的身分證明文件)上所顯 示的姓名。

A nomination form must be personally subscribed and signed by at least 5 subscribers. All the subscribers must be registered electors for the Indigenous Village/Composite Indigenous Village concerned. To avoid the risk of invalidation of the nomination if any subscriber is ineligible, the nomination form may contain more than 5 subscribers. If there are more than 10 subscribers, the supplementary sheet of page 3 of the nomination form must be used. Each sheet of page 3 should be marked with a consecutive serial number starting with "3 (1)". All pages (including all sheets of page 3) of the form must be submitted to the Returning Officer in one complete set. A candidate should check the eligibility of the subscribers. If for any reason a subscriber is found to be ineligible, his/her subscription will be disregarded. A candidate should also remind each of the subscribers to provide the name as shown on his/her identity document (being the identity document based on which the particulars of the subscriber are recorded in the Final Register).

 - An elector for a Village is entitled to subscribe the specified number of nomination forms only. The specified number of nomination forms means the number of nomination forms that is equivalent to the number of Indigenous Inhabitant Representative(s) to be returned for the Village at the election.

記錄在有關鄉村正式選民登記冊內的資料所依據的身分證明文件,通常是其香港身分證) 上所 顯示的姓名。候選人在填寫中文姓名時須嚴格依照在其身分證明文件上所顯示的繁體字或簡 體字寫法。未能遵守這項規定會延誤檢查身分證明文件工作及/或令候選人須返回選舉主任辦 事處更正寫法。如果選舉主任信納某候選人通常為人所知的姓名與其身分證明文件上所顯示 的姓名有所不同,該候選人可在別名一欄中加上該姓名。提名公告上顯示的候選人姓名(包括 別名)會印在選票上。根據《選舉程序(鄉郊代表選舉)規例》(第541章,附屬法例L)第12(1) 及(2)條,選舉主任必須將一份關於某人是否獲有效提名的決定的通知,送交該人及有關鄉郊 地區的每名獲有效提名的候選人。這份通知必須按各有關提名表格上所提供的主要住址送交。 For publication of the Notice of Nominations in the Government Gazette, please provide the name and principal residential address of the candidate in both Chinese and English. The candidate may refer to the Appendix for the points to note when filling in the Chinese name and principal residential address. The candidate must provide the name as shown on his/her identity document (being the identity document based on which the particulars of the candidate are recorded in the Final Register for the Village concerned, which is usually his/her Hong Kong Identity Card). The candidate should strictly follow the writing of his/her Chinese name on his/her identity document in Traditional Chinese or Simplified Chinese. Failure to comply with this requirement would cause a delay in checking the candidate's identity document and/or require him/her to return to the Returning Officer's office for rectification. If the Returning Officer is satisfied that the candidate is usually known by a name different from that shown on his/her identity document, that candidate may include such different name as his/her alias. The name (including alias) of the candidate as shown in the Notice of Nominations will be printed on ballot papers. According to section 12 (1) and (2) of the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541 sub. leg. L), the Returning Officer must send a notice of a decision that a person is validly nominated or is not validly nominated to the person concerned and each validly nominated candidate for the Rural Area Such a notice must be sent to the principal residential address(es) of the person(s)/candidate(s) concerned as given on the nomination forms.

- 7. 候選人只有在沒有香港身分證的情況下,才可填寫其他身分證明文件的類別及號碼。
 The candidate can provide his/her identity document type and number only if he/she does not have a Hong Kong Identity Card.

 - A nomination form should be handed in by the candidate <u>in person</u> (except where the Returning Officer, on application, allows another means of delivery) and received by the relevant Returning Officer within the nomination period from <u>5 May 2015</u> to <u>18 May 2015</u> (both days inclusive) during office hours (Monday to Friday: from 9 am to 5 pm; Saturday: from 9 am to 12 noon) on any day other than a general holiday.
- 9. 準候選人<u>應盡早遞交提名表格</u>,以便於<u>提名期結束前</u>,將提名表格上可能發現的錯誤更 正。 A prospective candidate is strongly advised to <u>submit his/her nomination form as early as practicable</u> so that any mistakes found in his/her nomination form can be rectified <u>before the close of nominations</u>.
- 10. 任何提名表格所載候選人姓名或其他重要資料如經更改,將可能不被選舉主任接納。
 The Returning Officer may not accept any nomination form on which the name or other important particulars of the candidate has/have been amended, altered or corrected.
- 11. 一般而言,除非選舉主任決定提名表格無效,否則獲提名的候選人即作為正式獲提名論,並可展開選舉活動。選舉主任就提名是否有效所作的決定,將為最終決定,除以選舉呈請提出質疑外,不可循任何法律程序提出質疑。
 - Generally, unless and until the Returning Officer decides that a nomination form is invalid, the candidate is deemed to stand nominated and he/she may hence carry out activities to promote his/her

election. The Returning Officer's decision on the validity of a nomination is final and cannot be questioned in any proceeding except by an election petition.

A nomination form will not be valid unless it contains the information as required in the Rural Representative Election Ordinance (Cap. 576) and the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541 sub. leg. L). The Returning Officer may request such other information from a candidate as he/she considers necessary to satisfy himself/herself as to the eligibility of the candidate and the validity of the nomination.

A candidate cannot be nominated for more than one Rural Area and cannot stand for both Indigenous Inhabitant Representative election and Resident Representative election/ Kaifong Representative election in this Rural By-election. When a candidate hands in his/her nomination form, he/she must have withdrawn his/her candidature in respect of all other Rural Areas, if any, or else his/her new nomination will be held to be invalid.

Eligibility for registration as an elector, disqualification for being registered as an elector, disqualifications from voting at an election (including a by-election), qualifications for and disqualifications from being nominated as a candidate or being elected as a Rural Representative are dealt with in sections 14, 15, 16, 22 and 23 of the Rural Representative Election Ordinance (Cap.

已登記為某鄉郊地區的選民的人如有以下情況,即喪失在該地區的選舉中投票的資格 - (由 2014 年第 5 號第 2 條修訂)

- (a) 他已不再有資格如此登記;
- (b)-(d) (由 2009 年第 7 號第 10 條廢除)
- (e) 他根據《精神健康條例》(第 136 章) 被裁斷為因精神上無行為能力而無能力處理和管理其財產及事務;或
- (f) 他是中華人民共和國或任何其他國家或地區的武裝部隊的成員。

When an elector is disqualified from voting at an election (section 14 of the Rural Representative Election Ordinance (Cap. 576))

A person registered as an elector for a Rural Area is disqualified from voting at an election for the Rural Area if the person- (Amended 5 of 2014 s. 2)

- (a) has ceased to be eligible to be so registered;
- (b)-(d) (Repealed 7 of 2009 s. 10)
- (e) is found under the Mental Health Ordinance (Cap. 136) to be incapable, by reason of mental incapacity, of managing and administering his property and affairs; or
- (f) is a member of the armed forces of the People's Republic of China or any other country or territory.

- (5) 任何人除非符合以下條件,否則沒有資格登記為原居鄉村或共有代表鄉村的選民一

When a person is disqualified from being nominated as a candidate and from being elected as a Rural Representative (section 23 of the Rural Representative Election Ordinance (Cap. 576))

- (1) A person is disqualified from being nominated as a candidate at an election, and from being elected as a Rural Representative for a Rural Area, if the person- (Amended 5 of 2014 s. 2)
- (a) is a judicial officer;
- (b) has, in Hong Kong or any other place, been sentenced to death or imprisonment (by whatever name called) and has not-
 - (i) served the sentence or undergone such other punishment as a competent authority may have substituted for the sentence; or
 - (ii) received a free pardon¹;
- (c) has been convicted of treason;

¹ The Court of First Instance delivered written judgment on 21 June 2012 on Wong Hin Wai v Secretary for Justice (HCAL 51/2012) and Leung Kwok Hung v Secretary for Justice (HCAL 54/2012) and declared section 39(1)(b) of the Legislative Council Ordinance (which is similar to section 23(1)(b) of Rural Representative Election Ordinance) to be unconstitutional. On 12 July 2012, the Administration announced its decision not to appeal against the judgment. The future Rural Representative elections will be organised in accordance with the prevalent electoral laws. Any person who would like to be nominated as a candidate for a Rural Representative election and is doubtful about his/her eligibility for nomination may seek independent legal advice.
