Notes on Completion of Information Sheet in Relation to Election Advertisements

1. 根據《選舉程序 (鄉郊代表選舉) 規例》(第 541L 章)第 91 條,"發布"是指印刷、展示、展覽、分發、張貼、公布或以任何其他方式使公眾獲知,並包括繼續發布。

According to section 91 of the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541 L), "publish" means print, display, exhibit, distribute, post up, publicly announce or make publicly known by any other means, and includes continue to publish.

- 2. "准許"是指私人土地的擁有人或佔用人或政府土地主管當局根據《公眾衞生及市政條例》(第 132 章) 第 104A 條,就候撰人在該土地展示或張貼招貼或海報而給予的書面准許。
 - "Permission" means the written permission of the owner or the occupier of any private land or the authority of any government land given pursuant to section 104A of the Public Health and Municipal Services Ordinance (Cap.132) for a candidate to display or affix a bill or poster on such land.
- 3. "同意書"是指任何人或組織根據《選舉(舞弊及非法行為)條例》(第554章)第27條,就候選人發布或授權發布收納了該人或組織的姓名、名稱或標識或跟該人或組織的姓名、名稱或標識;或與該人或組織有關聯的姓名、名稱或標識或與跟該人或組織有關聯的姓名、名稱或標識甚為相似的姓名、名稱或標識;或該人的圖像的選舉廣告,而給予的書面同意。

"Consent" means the consent in writing given by any person or organization pursuant to section 27 of the Election (Corrupt and Illegal Conduct) Ordinance (Cap. 554) for a candidate to publish or authorize the publication of an election advertisement that includes the name or logo of or associated with the person or organization; or a name or logo that is substantially similar to the name or logo of or associated with the person or organization; or a pictorial representation of the person.

- 4. 在**發布**任何選舉廣告**後的1個工作天(即公眾假期及星期六以外的任何一天)內**,如候選人打算以印本形式呈交其任何選舉廣告作公眾查閱,候選人必須向有關鄉郊地區的選舉主任呈交有關廣告的文本兩份及相關的資料摘要一份。至於實際上不能或不便影印的選舉廣告,候選人則須呈交其彩色照片(明信片尺寸)兩張及相關的資料摘要一份。候選人必須確保遞交的選舉廣告詳情符合《選舉規例(鄉郊代表選舉)規例》(第541L章)第92條及《鄉郊代表選舉活動指引》第四章的規定及要求。
 - If a candidate wishes to submit election advertisements in a hard copy format for public inspection, he/she must deposit with the Returning Officer for the relevant rural area two copies each of the election advertisements together with this information sheet within 1 working day (i.e. any day other than a general holiday and Saturday) after they are published. In respect of the election advertisements which cannot be practically or conveniently photocopied, two postcard sized colour photographs of each election advertisement together with this information sheet must be provided. The candidate must ensure that the election advertisement particulars submitted complies with the rules and requirements as set out in section 92 of the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541L), and Chapter 4 of the "Guidelines on Election-related Activities in respect of the Rural Representative Election".
- 5. 如已向選舉主任繳存的選舉廣告資料摘要須要作出修正,候選人應向選舉主任繳存「已修正的選舉廣告資料通知書」(表格編號:HAD/C11/By-E),任何已修正的資料應在不遲於選舉日後 2 個工作天內(即 2016 年 5 月 31 日或之前)或在押後/延遲的選舉日之後的 2 個工作天內(如適用) 向選舉主任繳存。如候選人沒有繳存任何「已修正的選舉廣告資料通知書」(表格編號:HAD/C11/By-E),則此資料摘要將被視為依據,用以審查和核對候選人的「選舉開支及接受選舉捐贈之申報書及聲明書」(表格編號:HAD/C1/By-E)。 If subsequent correction to the information sheet deposited with the Returning Officer is required, the candidate should deposit with the Returning Officer a "Notification of Corrected Information in Relation to Election Advertisements" (Form no.: HAD/C11/By-E). Any such corrective information should be deposited with the Returning Officer not later than two working days after the postponed or adjourned polling day (i.e. on or before 31 May 2016) or not later than two working days after the postponed or adjourned polling day, where applicable. If no "Notification of Corrected Information in Relation to Election Advertisements" (Form no.: HAD/C11/By-E) has been so deposited, this information sheet will be used as one of the bases for examining and checking the "Return and Declaration of Election Expenses and Election Donations" (Form no.: HAD/C1/By-E) of the candidate.

 If the Returning Officer has not yet been appointed, the references in this information sheet to a Returning Officer are to be construed as a reference to the Director of Home Affairs.

(a) 資料用途

Purpose of Collection

The personal data and other related information supplied in connection with this information sheet will be used by the Home Affairs Department, the Returning Officer for the relevant rural area and government departments concerned for election-related purposes.

(b) <u>資料轉介</u>

Transfer of Information

A copy of the information sheet, permission or authorization, consent or election advertisement <u>will be made available</u> by the Returning Officer who has received them <u>for public inspection</u>. <u>All identity document numbers in the form will be covered before display</u>. The information concerned may be provided to other authorized departments/organizations/persons including but not limited to the law courts for election-related purposes.

(c) 索閱個人資料

Access to Personal Data

A person has the right to request access to and correction of the personal data he/she supplied in this information sheet in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).
