Notes on Completion of Application for Creating an Account of the Central Platform and Undertaking in respect of the Terms and Conditions in Using the Central Platform for Candidates

1. 為符合《選舉程序(鄉郊代表選舉)規例》(第541L章)第92(2)條與選舉廣告有關的公眾查閱規定, "中央平台"是指一個由民政事務總署署長或獲其授權的人士所維持以供候選人在發布選舉廣告後的1 個工作天(即公眾假期及星期六以外的任何一天)內上載選舉廣告詳情予公眾查閱的公開平台。候選人 必須確保上載的選舉廣告詳情內容符合《選舉程序(鄉郊代表選舉)規例》(第 541L 章)第 92 條及 《鄉郊代表選舉活動指引》第四章及附錄三的規定及要求。

To comply with the public inspection requirement governing election advertisements under section 92(2) of the Electoral Procedure (Rural Representative Election) Regulation (Cap 541L), the "Central Platform" refers to an open platform maintained by the Director of Home Affairs or a person authorized by him/her which allows a candidate to post election advertisement particulars, within 1 working day (i.e. any day other than a general holiday and Saturday) after the publication of an election advertisement for public inspection. The candidate must ensure that the election advertisement particulars uploaded complies with the rules and requirements as set out in section 92 of the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541L), and Chapter 4 and Appendix C of the "Guidelines on Election-related Activities in respect of the Rural Representative Elections".
