  - \*I/Each of us understand(s) that \*I/we must make a Declaration of Secrecy in advance and produce such Declaration of Secrecy and \*my/our Hong Kong Identity Card(s) when reporting to the Returning Officer on attending the counting station /ballot paper sorting station before commencement of the count on the polling day.
- 7. \*我/我們每人亦明白,\*我/我們不得-
  - \*I/Each of us further understand(s) that \*I/we **must not** –
  - (a) 向他人傳達在點票時取得的資料,包括任何一張選票所選之候選人; communicate to any person any information obtained at the counting of the votes including the candidate(s) for whom a vote has been given on any particular ballot paper;
  - (b) 觸摸、處理、分開或排列選票或封套; touch, handle, separate or arrange ballot papers or envelopes;
  - (c) 干擾或企圖干擾任何投票箱、選票結算書、選票結算核實書或覆核書、或其他有關的選舉物料;或 interfere with or attempt to interfere with any ballot boxes, ballot paper accounts, verifications or reverifications of such accounts or other relevant election materials; or
  - (d) 在點票過程拍影片、拍照、錄音或錄影。 Film, take photograph or make any audio or video recording during the counting process.

8. \*我/我們每人均明白,倘\*我/我們在點票站/選票分流站內或其鄰近範圍內行為不檢,或不遵從選舉主任的任何合法指示,即屬違法,可被判罰款及監禁,並可能會被選舉主任命令立即離開該地方。倘\*我/我們沒有離開,可能會被警務人員或獲選舉主任以書面授權的人員逐離該地方。\*我/我們被逐離後,除非獲得選舉主任的許可,否則不得再次進入點票站/選票分流站。

\*I/Each of us also understand(s) that if \*I/we misconduct \*myself/ourselves at or in the vicinity of the counting station/ballot paper sorting station, or fail to obey any lawful order of the Returning Officer, \*I/we shall commit an offence punishable with a fine and imprisonment and may be ordered by the Returning Officer to leave the area immediately. \*My/Our failure to leave the area may result in \*my/our being removed by a police officer or a person authorized by the Returning Officer in writing. If \*I am/we are so removed, \*I/we may not re-enter the counting station/ballot paper sorting station except with the permission of the Returning Officer.

### 填寫監察點票代理人委任通知書說明

### **Notes on Completion of Notice of Appointment of Counting Agents**

1. 除非候選人以指明表格明文另作示明,有關代理人須當作是為在預定日期進行的投票中或(如適用的話)遭押 後或延遲的該次投票中所投的票的點算而委任。

The agent is to be regarded as being appointed for the counting of the votes cast in the poll to be conducted on the scheduled date and (where applicable) the postponed or adjourned poll, unless the candidate expressly indicates otherwise in the specified form.

2. 村代表選舉的候選人或其選舉代理人可**委任不超過 2 名監察點票代理人**,而街坊代表選舉的候選人或其選舉代理人則只可**委任 1 名監察點票代理人**。凡年滿 18 歲的香港身分證持有人均可被委任為監察點票代理人。候選人或其選舉代理人不應委任選舉主任、助理選舉主任、或任何已受選舉主任或民政事務總署署長委任協助進行投票或點票的人士(通常為政府公職人員)為其監察點票代理人。

For Village Representative Election, a candidate or his election agent <u>may appoint not more than 2 counting agents</u>. For Kaifong Representative Election, a candidate or his election agent <u>may only appoint 1 counting agent</u>. Any person who is a holder of a Hong Kong Identity Card and has attained the age of 18 years may be appointed as a counting agent. However, a candidate or his election agent should ensure that he/she does not appoint as his/her counting agent the Returning Officer, Assistant Returning Officer, or any person (usually a government officer) already appointed by the Returning Officer or the Director of Home Affairs to assist at the poll or at the count.

- 3. 本通知書的第一部分應由候選人或選舉代理人填寫及簽署。第二部分應由各個監察點票代理人填寫及簽署。 Part I of the notice should be completed and signed by the candidate or the election agent. Part II should be completed and signed by each of the counting agents.
- 4. 委任監察點票代理人的委任通知書,須於投票日前 3 天之前(即 2016 年 5 月 25 日或之前)藉專人送遞、郵遞、電子郵件或圖文傳真方式送交有關鄉郊地區的選舉主任,或於投票日由候選人或選舉代理人親自向有關鄉郊地區的選舉主任或助理選舉主任(如屬選票分流站)遞交。逾期遞交的通知將不予接納。監察點票代理人的委任,在選舉主任或助理選舉主任接獲委任通知書後始生效。

Notice of appointment of counting agents must either be delivered to the Returning Officer for the relevant rural area by hand, by post, by electronic mail or by facsimile transmission before the 3 days preceding polling day (i.e. on or before 25 May 2016), or be given by the candidate or the election agent in person to the Returning Officer for the relevant rural area or the Assistant Returning Officer (in case of a ballot paper sorting station) on the polling day. Late submissions will not be accepted. The appointment of counting agents will not be effective until the notice of appointment is received by the Returning Officer or the Assistant Returning Officer, as may be appropriate.

#### (a) 資料用途

就此通知書提供的個人及其他有關的資料,會供民政事務總署、有關鄉郊地區的選舉主任、選票分流站的助 理選舉主任及有關的政府部門用於與選舉有關的用途。

### **Purpose of Collection**

The personal data and other related information supplied in connection with this notice will be used by the Home Affairs Department, the Returning Officer for the relevant rural area, the Assistant Returning Officer for the ballot paper sorting station and government departments concerned for election-related purposes.

#### (b) 資料轉介

此通知書內的資料可能會提供予其他獲授權的部門/機構/人士,包括但不限於法院,用於與選舉有關的用途。

### **Transfer of Information**

The information provided in this notice may be provided to other authorized departments/organizations/persons including but not limited to law courts for election-related purposes.

#### (c) 索閱個人資料

任何人有權根據《個人資料(私隱)條例》(第486章)的條文要求索閱及改正他/她所提供的個人資料。

## Access to Personal Data

A person has the right to request access to and correction of the personal data he/she supplied in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).

#### (d) 個人資料保障原則

請注意,候選人/選舉代理人在收集第三者的個人資料以填寫有關通知書時,須遵守《個人資料(私隱)條例》(第 486 章)附表 1 的保障資料原則,特別是第 4 原則,即採取所有切實可行的步驟,以確保資料受到保障而不受未獲准許的或意外的查閱和處理。

#### **Personal Data Protection Principle**

Candidates/election agents are reminded to observe the Data Protection Principles in Schedule 1 to the Personal Data (Privacy) Ordinance (Cap.486) in collecting personal data of a third person in completing the relevant notice, in particular Principle 4 concerning the requirement to take all practicable steps to ensure that personal data are protected against unauthorized or accidental access and processing.
