The Notes below are for reference only. For legislation concerning nomination matters, please refer to the Rural Representative Election Ordinance (Cap. 576), the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554) and other relevant legislation, including but not limited to the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541L).

Each nomination form may only be used for the nomination of **ONE** candidate. Candidate should submit a duly completed nomination form (including Page 1 to Page 10) to the relevant Returning Officer. If a candidate downloads the nomination form from the website of the Home Affairs Department, please print on **A4 size white papers**. Please do not use pencil or erasable pen to fill in the nomination form.

Candidate may choose to separately provide his/her contact information for the media and public. The supply of such contact information is optional. Nevertheless, the provision of such information to the media and public may facilitate them to contact the candidate concerned directly.

3. 根據《鄉郊代表選舉條例》(第 576 章)第 25 條及《選舉程序(鄉郊代表選舉)規例》(第 541L 章)第 7 條，每份提名表格須由**最少 5 名有關原居鄉村／共有代表鄉村的已登記選民親自簽署作為提名人**。候選人不得以提名人身分在其提名表格內簽署。為避免因有提名人不符合資格而令提名失效，提名表格可由多於 5 名提名人簽署。如超過 10 名提名人，候選人可使用「鄉郊補選(原居民代表)提名人補充頁」，請在每張補充頁填上由“補充頁(1)”開始的順序頁碼。此表格的每一頁(包括所有補充頁)在遞交提名表格時必須一併交予有關的選舉主任。候選人應查證提名人的資格，並提醒每名提名人必須在此表格上親自簽署。倘若基於任何原因，某名提名人被發現不符合資格在提名表格上提名，他／她的提名將不予理會。候選人亦須提醒每名提名人應填寫在其身分證明文件(指提名人記錄在有關鄉村正式選民登記冊內的資料所依據的身分證明文件)上所顯示的姓名。

According to section 25 of the Rural Representative Election Ordinance (Cap. 576) and section 7 of the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541L), a nomination form must be **personally signed and subscribed by at least 5 registered electors for the relevant Indigenous Village/Composite Indigenous Village**. A candidate should not sign as a subscriber in his/her nomination form. To avoid the risk of invalidation of the nomination if any subscriber is unqualified, the nomination form may be subscribed by more than 5 subscribers. If there are more than 10 subscribers, candidate may use the “Rural By-election (Indigenous Inhabitant Representative) Supplementary Sheet for Subscribers”. Each supplementary sheet should be marked with a consecutive serial number starting with “Supplementary Sheet (1)”. All pages (including all supplementary sheets) of this form must be returned to the relevant Returning Officer in one complete set. A candidate should check the qualification of the subscribers and remind each subscriber to personally sign this form. If for any reason a subscriber is found not to be qualified to subscribe the nomination form, his/her subscription will be disregarded. A candidate should also remind each subscriber to

provide the name as shown on his/her identity document (being the identity document based on which the particulars of the subscriber are recorded in the final register of the relevant Village).

A registered elector is only entitled to subscribe the specified number of nomination form(s) in respect of his/her own Indigenous Village/Composite Indigenous Village. The specified number of nomination forms means the number of nomination forms that is equivalent to the number of Indigenous Inhabitant Representative(s) to be returned for the Village at the by-election.

To facilitate the publication of the Notice of Valid Nominations and other specified notices in the Government Gazette in accordance with the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541L), please provide the name and address of the candidate in both Chinese and English. A candidate can fill in his/her office or business address, correspondence address¹, residential address or post office box number as address. The address information should be complete (see PART II of Appendix). Besides, a candidate must provide the name as shown on his/her identity document (being the identity document based on which the particulars of the candidate are recorded in the final register of the relevant Village, which is usually his/her Hong Kong Identity Card) (see PART I of Appendix). The candidate should strictly follow the writing of his/her Chinese name as shown on his/her identity document in Traditional Chinese or Simplified Chinese (as the case may be). Failure to comply with this requirement would cause a delay in checking the candidate's identity document and/or require him/her to return to the relevant Returning Officer's office for rectification. If the relevant Returning Officer is satisfied that the candidate is usually known by a name different from that shown on his/her identity document, that candidate may include such different name as his/her alias. **The name (including alias) of the candidate as shown in the Notice of Valid Nominations will be printed on the ballot papers.** Candidates may refer to the Appendix for the points to note when filling in the Chinese name and address.

6. 根據《選舉程序(鄉郊代表選舉)規例》(第 541L 章)第 12(1)及(2)條，有關的選舉主任必須將一份關於某人是否獲有效提名的決定的書面通知，送交該人及有關鄉郊地區的每名獲有效提名的候選人。這份通知必須按各候選人在有關提名表格上所提供的地址送交。除有關提名是否有效的通知外，所有由民政事務總署或有關的選舉主任發出的信件、重要資料及公告，將會以電郵、傳真或按提名表格上所提供的通訊地址(如有的話)送交給候選人。

If an address of another person/organization is used as correspondence address, the prior consent of the person/organization concerned must be obtained.

According to section 12(1) and (2) of the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541L), the relevant Returning Officer must send a written notice of his/her decision that a person is validly nominated or is not validly nominated to the person concerned and each validly nominated candidate for the Rural Area concerned. Such a notice must be sent to the address provided by each candidate concerned as given on his/her nomination form. All correspondence, important information and notices, except the relevant notices on the validity of a nomination, from the Home Affairs Department or the relevant Returning Officer will be sent to the candidate by email, by fax or by mail to the correspondence address, if provided, as given in the nomination form.

7. 候選人可選擇在提名表格填寫其職業及政治聯繫的資料，此等資料將會供公眾查閱。如候選人公開其政治聯繫時提及任何團體的名稱，他／她必須事先取得有關團體的書面同意。候選人的姓名、性別及職業的資料亦會在鄉郊代表選舉網站發布。如候選人在「候選人簡介」的方格表上提供資料(例如職業)，有關資料應與提名表格上的資料無抵觸。A candidate may choose whether to state his/her occupation and political affiliation in the nomination form, which will be made available for public inspection. If the candidate mentions the name of any organization when stating his/her political affiliation, he/she must seek the written consent of the organization concerned beforehand. The name, sex and occupation of the candidate will also be published in the Rural Representative Election website. Information (such as occupation) provided by the candidate in the Grid Paper for “Introduction to Candidates” should not be inconsistent with information stated in the nomination form.
8. 提名表格必須在提名期：**2025年3月18日至2025年3月31日內**(首尾兩天包括在內)，除公眾假期外的任何日子，於通常辦公時間內(星期一至星期五：上午九時至下午五時；星期六：上午九時至中午十二時)由候選人**親自**(已向選舉主任申請並獲認可以任何其他方式呈交者除外)送交給有關的選舉主任。根據《選舉程序(鄉郊代表選舉)規例》(第541L章)第2A(3)條，如提名期的最後一日適逢惡劣天氣警告日(在該工作日中，在通常辦公時間內有任何時間有烈風警告或暴雨警告生效；烈風警告及暴雨警告的涵義與該詞在《司法程序(烈風警告期間聆訊延期)條例》(第62章)中的涵義相同)，提名期將會延長至並非惡劣天氣警告日的下一個工作日結束。
A nomination form must be handed in by the candidate **in person** (except where the Returning Officer has, on application, authorized any other manner of submission) and received by the relevant Returning Officer within the nomination period from **18 March 2025 to 31 March 2025** (both days inclusive) during ordinary business hours (Monday to Friday: from 9 am to 5 pm; Saturday: from 9 am to 12 noon) on any day other than a general holiday. According to section 2A(3) of the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541L), if the last day of the nomination period falls on an inclement weather warning day (a working day on which a gale warning or a rainstorm warning is in force at any time during ordinary business hours; gale warning and rainstorm warning have the same meaning as in the Judicial Proceedings (Adjournment During Gale Warnings) Ordinance (Cap. 62)), the nomination period will be extended to end on the next working day which is not an inclement weather warning day.
9. 準候選人應盡早遞交提名表格，以便於提名期結束前，將提名表格上可能發現的錯處更正。
A prospective candidate is strongly advised to **submit his/her nomination form as early as practicable** so that any mistakes found in his/her nomination form can be rectified **before the end of nomination period**.
10. 任何提名表格所載候選人姓名或其他重要資料如經更改，將可能不會被有關的選舉主任接納。
The relevant Returning Officer may not accept any nomination form on which the name or other important particulars of the candidate has/have been amended, altered or corrected.

11. 選舉主任就提名是否有效所作的決定，只可藉選舉呈請予以質疑。
The Returning Officer's decision on the validity of a nomination may be questioned only by an election petition.
12. 提名表格必須按《鄉郊代表選舉條例》(第 576 章) 及《選舉程序(鄉郊代表選舉)規例》(第 541L 章) 的規定列載所需的資料，提名方才有效。根據《選舉程序(鄉郊代表選舉)規例》(第 541L 章) 第 7(3)條，在決定候選人是否合乎資格及其提名是否有效時，有關的選舉主任可要求候選人提供提名表格沒有涵蓋而該主任認為需要的資料。
A nomination will not be valid unless the nomination form contains the information as required in the Rural Representative Election Ordinance (Cap. 576) and the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541L). According to section 7(3) of the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541L), the Returning Officer concerned may require the candidate to furnish any other information which is not covered by the nomination form as that Officer considers necessary in order to be satisfied that the candidate is eligible to be nominated and as to the validity of the nomination.
13. 候選人不得在是次鄉郊補選中在多於一個鄉郊地區獲得提名；亦不可同時參選原居民代表選舉及居民代表選舉／街坊代表選舉。候選人呈交提名表格時，他／她必須已撤回在是次鄉郊補選中所有其他鄉郊地區的提名(如有)，否則，他／她其後所呈交的提名表格將被當作無效。
A candidate cannot be nominated for more than one Rural Area and cannot stand for both Indigenous Inhabitant Representative election and Resident Representative election/Kaifong Representative election in this Rural By-election. When a candidate submits his/her nomination form, he/she must have withdrawn his/her nomination in respect of all other Rural Area(s) in this Rural By-election, if any, otherwise his/her subsequently submitted nomination form will be treated as invalid.
14. 根據《選舉程序(鄉郊代表選舉)規例》(第 541L 章) 第 90 條，任何人在與選舉有關的文件中作出他／她明知在要項上屬虛假的陳述，或罔顧實情地在與選舉有關的文件中作出在要項上不正確的陳述，或在與選舉有關的文件中遺漏任何要項，即屬犯罪。
In accordance with section 90 of the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541L), any person, who, in an election related document, makes a statement which that person knows to be false in a material particular or recklessly makes a statement which is incorrect in a material particular or omits a material particular commits an offence.
15. 候選人如欲撤回提名，他／她可填寫一份「候選人退選通知書」的指明表格(HAD/C5/By-E)，並於提名期結束前送遞予有關的選舉主任。
If a candidate wishes to withdraw his/her nomination, he/she may do so by completing and delivering to the Returning Officer concerned a "Notice of Withdrawal of Candidature" in a specified form (HAD/C5/By-E) before the end of nomination period.
16. 本提名表格第二部分必須於見證人在場下由候選人填寫及簽署。見證人必須年滿 18 歲並持有身分證明文件。見證人必須填寫及簽署本提名表格第三部分。根據《鄉郊代表選舉條例》(第 576 章) 第 2(1)條，“身分證明文件”(identity document)指—
PART II of this nomination form should be completed and signed by a candidate in the presence of a witness who shall be in possession of an identity document and aged 18 years or over. The witness is required to complete PART III of this nomination form and sign thereunder. According to section 2(1) of the Rural Representative Election Ordinance (Cap. 576), "identity document" (身分證明文件) means—
 - (a) 身分證；或
an identity card; or

- (b) 向某人發出而可獲選舉登記主任接受為該人的身分證明的任何其他文件。
any other document issued to a person that is acceptable to the Electoral Registration Officer as proof of the person's identity.

18. 根據《鄉郊代表選舉條例》(第 576 章) 第 22、23 及 24 條，有關獲提名為候選人的資格、喪失獲提名為候選人及當選為鄉郊代表的資格的情況及獲提名的候選人須遵從的規定載列如下，以供參考—

Eligibility for being nominated as a candidate, disqualification from being nominated as a candidate and from being elected as a Rural Representative and requirements to be complied with by persons nominated as candidates are dealt with in sections 22, 23 and 24 of the Rural Representative Election Ordinance (Cap. 576) which are reproduced below for reference—

- (2) 符合以下條件的人方有資格在原居鄉村或共有代表鄉村選舉中獲提名為候選人—

Who is eligible to be nominated as a candidate (section 22 of the Rural Representative Election Ordinance (Cap. 576))

- (2) A person is eligible to be nominated as a candidate at an election for an Indigenous Village or a Composite Indigenous Village only if the person—
- (a) is an indigenous inhabitant of the Village;
 - (b) has reached 21 years of age;
 - (c) is registered, and eligible to be registered, as an elector for the Village;
 - (d) is not disqualified from voting at the election;
 - (e) is not disqualified from being nominated as a candidate at the election, or from being elected as an Indigenous Inhabitant Representative for the Village, by virtue of section 23 or any other law;
 - (f) is a Hong Kong permanent resident; and
 - (g) ordinarily resides in Hong Kong.
- (3) A Rural Representative is not eligible to be nominated as a candidate at a rural by-election.
- (4) A person is not eligible to be nominated as a candidate at an election for a Rural Area if the person is currently nominated as a candidate at an election for another Rural Area.

- (2) 任何人如根據《精神健康條例》(第 136 章) 被裁斷為因精神上無行為能力而無能力處理和管理其財產及事務，即喪失在選舉中獲提名為候選人的資格；但根據本款喪失資格的人如在其後根據該條例獲裁斷為已有能力處理和管理其財產及事務，即有資格在選舉中獲提名為候選人。
- (3) 任何人如根據《精神健康條例》(第 136 章) 被裁斷為因精神上無行為能力而無能力處理和管理其財產及事務，即喪失當選為鄉郊代表的資格；但根據本款喪失資格的人如在其後根據該條例獲裁斷為已有能力處理和管理其財產及事務，即有資格當選為鄉郊代表。
- (6) 在第(1A)款中——
- 指明誓言 (specified oath) 指根據法律作出的以下誓言：宣誓者會擁護《基本法》、效忠中華人民共和國香港特別行政區。

When a person is disqualified from being nominated as a candidate and from being elected as a Rural Representative (section 23 of the Rural Representative Election Ordinance (Cap. 576))

- (1) A person is disqualified from being nominated as a candidate at an election, and from being elected as a Rural Representative for a Rural Area, if the person—
 - (a) is a judicial officer;
 - (b) has, in Hong Kong or any other place, been sentenced to death or imprisonment (by whatever name called) and has not—
 - (i) served the sentence or undergone such other punishment as a competent authority may have substituted for the sentence; or
 - (ii) received a free pardon²;
 - (c) has been convicted of an offence endangering national security;
 - (d) on the date of nomination, or of the election, is serving a sentence of imprisonment;
 - (e) without limiting paragraph (b), where the election is to be held or is held within 5 years after the date of the person's conviction, is or has been convicted—
 - (i) in Hong Kong or any other place, of an offence for which the person has been sentenced to imprisonment, whether suspended or not, for a term exceeding 3 months without the option of a fine;
 - (ii) of having engaged in corrupt or illegal conduct;
 - (iii) of an offence against Part II of the Prevention of Bribery Ordinance (Cap. 201); or
 - (iv) of any offence prescribed by the EAC Regulations;
 - (f) is ineligible to be a candidate at the election, or to be elected as a Rural Representative for the Rural Area, because of the operation of this Ordinance or any other law;
 - (g) is a representative or a salaried functionary of the government of a place outside Hong Kong;
 - (h) is a member of any national, regional or municipal legislature, assembly or council of a place outside Hong Kong, other than a people's congress or people's consultative body of the People's Republic of China, whether established at the national level or local level; or
 - (i) is an undischarged bankrupt or, within the previous 5 years, has either obtained a discharge in bankruptcy or has entered into a voluntary arrangement within the meaning of the Bankruptcy Ordinance (Cap. 6) with the person's creditors, in either case without paying the creditors in full.
- (1A) A person is disqualified from being nominated as a candidate at an election, and from being elected as a Rural Representative for a Rural Area, if the election is held or is to be held within 5 years after—
 - (a) the date on which the person vacates an office, or is disqualified from holding or entering on an office, under the law, for declining or neglecting to take a specified oath; or
 - (b) the date on which the person is declared or decided in accordance with any law—
 - (i) to be in breach of a specified oath; or

² The Court of First Instance delivered written judgment on 21 June 2012 on *Wong Hin Wai v Secretary for Justice* (HCAL 51/2012) and *Leung Kwok Hung v Secretary for Justice* (HCAL 54/2012) and declared section 39(1)(b) of the Legislative Council Ordinance (which is similar to section 23(1)(b) of the Rural Representative Election Ordinance) to be unconstitutional. On 12 July 2012, the Administration announced its decision not to appeal against the judgment. The future Rural Representative elections will be organized in accordance with the prevalent electoral laws. Any person who would like to be nominated as a candidate for a Rural Representative election and is doubtful about his/her eligibility for nomination may seek independent legal advice.

- (ii) to have failed to fulfil the legal requirements and conditions on upholding the Basic Law and bearing allegiance to the Hong Kong Special Administrative Region of the People's Republic of China.
- (2) A person is disqualified from being nominated as a candidate at an election if the person is found under the Mental Health Ordinance (Cap. 136) to be incapable, by reason of mental incapacity, of managing and administering his property and affairs, but a person disqualified under this subsection is eligible to be nominated as a candidate at an election if it is subsequently found under that Ordinance that the person has become capable of managing and administering his property and affairs.
- (3) A person is disqualified from being elected as a Rural Representative if the person is found under the Mental Health Ordinance (Cap. 136) to be incapable, by reason of mental incapacity, of managing and administering his property and affairs, but a person disqualified under this subsection ceases to be disqualified if it is subsequently found under that Ordinance that the person has become capable of managing and administering his property and affairs. (Amended 5 of 2014 s. 2)
- (6) In subsection (1A)—
specified oath (指明誓言) means an oath taken under the law that the oath-taker will uphold the Basic Law and bear allegiance to the Hong Kong Special Administrative Region of the People's Republic of China.

What requirements are to be complied with by persons nominated as candidates (section 24 of the Rural Representative Election Ordinance (Cap. 576))

A person is not validly nominated as a candidate for an election for a Rural Area unless the nomination form includes or is accompanied by a declaration, signed by the person, to the effect that the person will uphold the Basic Law and pledge allegiance to the Hong Kong Special Administrative Region.

In accordance with section 24 of the Rural Representative Election Ordinance (Cap. 576), a candidate must declare in the nomination form that he/she will uphold the Basic Law and pledge allegiance to the Hong Kong Special Administrative Region. Upholding the Basic Law means to uphold all the provisions of the Basic Law, including but not limited to the following provisions—

第一條

香港特別行政區是中華人民共和國不可分離的部分。

Article 1

The Hong Kong Special Administrative Region is an inalienable part of the People's Republic of China.

第十二條

香港特別行政區是中華人民共和國的一個享有高度自治權的地方行政區域，直轄於中央人民政府。

Article 12

The Hong Kong Special Administrative Region shall be a local administrative region of the People's Republic of China, which shall enjoy a high degree of autonomy and come directly under the Central People's Government.

第一百五十九(四)條

本法的任何修改，均不得同中華人民共和國對香港既定的基本方針政策相抵觸。

Article 159(4)

No amendment to this Law shall contravene the established basic policies of the People's Republic of China regarding Hong Kong.

20. 某人若符合正面清單則屬「擁護《基本法》、效忠中華人民共和國香港特別行政區」，而他／她若作出或意圖作出負面清單所列行為，則屬不符合「擁護《基本法》、效忠中華人民共和國香港特別行政區」。《釋義及通則條例》(第1章)第3AA條載列如下：
A person upholds the Basic Law and bears allegiance to the Hong Kong Special Administrative Region of the People's Republic of China ("HKSAR") if the positive list is satisfied; and that the person does not uphold the Basic Law and bear allegiance to the HKSAR if the person does or intends to do any of the things set out in the negative list. Section 3AA of the Interpretation and General Clauses Ordinance (Cap.1) is reproduced below—

對擁護《基本法》、效忠特區的提述 (《釋義及通則條例》(第1章)第3AA條)

- (1) 任何人如一
- (a) 擁護《中華人民共和國憲法》及《基本法》確立的香港特別行政區的憲制秩序；
 - (b) 擁護中華人民共和國國家主權、統一、領土完整和國家安全；
 - (c) 擁護—
 - (i) 香港特別行政區是中華人民共和國不可分離的部分；
 - (ii) 中華人民共和國對香港特別行政區行使主權；及
 - (iii) 中央根據《基本法》對香港特別行政區行使管治權力；
 - (d) 擁護“一國兩制”原則的落實，維護香港特別行政區的政治體制；
 - (e) 擁護在《基本法》的框架下，保持香港特別行政區繁榮穩定的目的；及
 - (f) 忠於香港特別行政區，維護香港特別行政區的利益，即屬擁護《基本法》、效忠中華人民共和國香港特別行政區。
- (2) 在第(1)款中，提述擁護，即提述在意圖上及言行上均真心地及真誠地遵守、支持、維護及信奉。
- (3) 任何人當作出或意圖作出以下任何行為時，不屬擁護《基本法》、效忠中華人民共和國香港特別行政區—
- (a) 作出或進行危害國家安全的行為或活動，包括—
 - (i) 作出《基本法》第23條規定禁止的行為；
 - (ii) 犯《中華人民共和國香港特別行政區維護國家安全法》規定的罪行；及
 - (iii) 犯成文法則或普通法規定的關於危害國家安全的罪行；
 - (b) 拒絕承認中華人民共和國對香港特別行政區擁有並行使主權，包括反對中央政權機關按照—
 - (i) 《中華人民共和國憲法》；
 - (ii) 《基本法》；或
 - (iii) 《中華人民共和國香港特別行政區維護國家安全法》，履行職務和職能；
 - (c) 拒絕承認香港特別行政區作為中華人民共和國一個地方行政區域的憲制地位；
 - (d) 宣揚或支持“港獨”主張，包括—
 - (i) 主張、推動或實施香港“獨立建國”；
 - (ii) 參與以“香港獨立”為宗旨的組織；
 - (iii) 主張、推動或實施“自決主權或治權”、“全民公投”、“全民制憲”等活動，或參與以“自決”為宗旨的組織；及

- (iv) 主張或推動香港轉歸外國統治；
- (e) 尋求外國政府或組織干預香港特別行政區的事務；
- (f) 作出損害或有傾向損害《基本法》中以行政長官為主導的政治體制秩序的行為，包括—
 - (i) 以非法手段強迫或威嚇行政長官改變某項政策或提交立法會審議的議案；
 - (ii) 無差別地反對特區政府提出的議案，並—
 - (A) 意圖以此要脅特區政府；
 - (B) 意圖以此使特區政府無法正常履行職務和職能；或
 - (C) 意圖以此逼使行政長官下台及推翻特區政府；及
 - (iii) 利用特區政府舉行的選舉，組織或實施(或煽動他人組織或實施)任何形式的對抗中央人民政府和特區政府的“變相公投”；
- (g) 作出損害或有傾向損害香港特別行政區的整體利益的行為；
- (h) 公開及故意以焚燒、毀損、塗劃、玷污、踐踏等方式侮辱國旗或國徽或區旗或區徽；
- (i) 侮辱或貶損國歌或國家主權的任何其他象徵和標誌。

References to upholding Basic Law and bearing allegiance to HKSAR (section 3AA of the Interpretation and General Clauses Ordinance (Cap.1))

- (1) A person upholds the Basic Law and bears allegiance to the Hong Kong Special Administrative Region of the People’s Republic of China if the person—
 - (a) upholds the constitutional order of the Hong Kong Special Administrative Region established by the Constitution of the People’s Republic of China and the Basic Law;
 - (b) upholds the national sovereignty, unity, territorial integrity and national security of the People’s Republic of China;
 - (c) upholds—
 - (i) the fact that the Hong Kong Special Administrative Region is an inalienable part of the People’s Republic of China;
 - (ii) the People’s Republic of China’s exercise of sovereignty over the Hong Kong Special Administrative Region; and
 - (iii) the Central Authorities’ exercise of governance over the Hong Kong Special Administrative Region under the Basic Law;
 - (d) upholds the implementation of “one country, two systems” principle, and safeguards the political structure of the Hong Kong Special Administrative Region;
 - (e) upholds the objective to maintain the prosperity and stability of the Hong Kong Special Administrative Region within the framework of the Basic Law; and
 - (f) is loyal to, and safeguards the interests of, the Hong Kong Special Administrative Region.
- (2) In subsection (1), a reference to uphold is a reference to intend to genuinely and truthfully observe, support, maintain and embrace, and genuinely and truthfully observe, support, maintain and embrace in words and deeds.
- (3) A person does not uphold the Basic Law and bear allegiance to the Hong Kong Special Administrative Region of the People’s Republic of China when the person does, or intends to do, any of the following—
 - (a) commits acts or carries out activities that endanger national security, including—
 - (i) commits an act required by Article 23 of the Basic Law to be prohibited;
 - (ii) commits an offence under the Law of the People’s Republic of China on Safeguarding National Security in the Hong Kong Special Administrative Region (a translation of “《中華人民共和國香港特別行政區維護國家安全法》”); and
 - (iii) commits an offence relating to endangering national security under an

- enactment or under the common law;
- (b) refuses to recognize the People’s Republic of China’s sovereignty over the Hong Kong Special Administrative Region and the exercise of the sovereignty, including objecting to the performance of duties and functions by the body of central power in accordance with—
 - (i) the Constitution of the People’s Republic of China;
 - (ii) the Basic Law; or
 - (iii) the Law of the People’s Republic of China on Safeguarding National Security in the Hong Kong Special Administrative Region (a translation of “《中華人民共和國香港特別行政區維護國家安全法》”);
 - (c) refuses to recognize the constitutional status of the Hong Kong Special Administrative Region as a local administrative region of the People’s Republic of China;
 - (d) advocates or supports “Hong Kong independence”, including—
 - (i) pursues, promotes or implements “independence and state-building” of Hong Kong;
 - (ii) participates in an organization the object of which is “Hong Kong independence”;
 - (iii) pursues, promotes or implements an activity for “self-determination of sovereignty or jurisdiction”, “referendum” or “devising constitution by all people”, or participates in an organization the object of which is “self-determination”; and
 - (iv) pursues or promotes the reign over Hong Kong to be transferred to a foreign country;
 - (e) solicits interference by foreign governments or organizations in the affairs of the Hong Kong Special Administrative Region;
 - (f) commits acts that undermine or have a tendency to undermine the order of the political structure led by the Chief Executive, contained in the Basic Law, including—
 - (i) compels or overawes the Chief Executive by any unlawful means to change a policy, or a motion to be submitted to the Legislative Council for consideration;
 - (ii) indiscriminately objects to the Government’s motion, and with this—
 - (A) intends to threaten the Government;
 - (B) intends to render the Government incapable of performing its duties and functions as normal; or
 - (C) intends to force the Chief Executive to step down and to overthrow the Government; and
 - (iii) makes use of an election held by the Government to organize or implement, or to incite another person to organize or implement, a “de facto referendum” in any form to confront the Central People’s Government and the Government;
 - (g) commits acts that undermine or have a tendency to undermine the overall interests of the Hong Kong Special Administrative Region;
 - (h) desecrates the national flag or national emblem, or regional flag or regional emblem, by publicly and wilfully burning, mutilating, scrawling on, defiling or trampling on it;
 - (i) insults or disrespects the national anthem or any other symbol and sign of national sovereignty.
