- 當收取每項價值 1,000 元以上的選舉捐贈(不論是以金錢、貨品或服務形式抵付)時,候選人必須向捐 贈者發出收據,載明捐贈者的姓名或名稱及地址(一如捐贈者所提供的資料)及該項選舉捐贈的詳情。 捐贈者可選擇披露其屬意的地址,如其辦事處或業務地址、通訊地址、住址或郵政信箱號碼。
 On receiving each election donation (whether by way of money, goods or service) of more than \$1,000 in value, candidate must issue to the donor a receipt which specifies the name and address of the donor (as supplied by the donor) and the particulars of such election donation. The donor may choose to disclose an address that he/she/it prefers, for example, his/her/its office or business address, correspondence address, residential address or post office box number.
