(Note: According to Chapter 7 of the “Guidelines on Election-related Activities in respect of the Rural Representative Election”, a candidate **must inform the Returning Officer (“RO”) for the relevant rural area of his/her intention to display election advertisements at designated spots in writing within the nomination period.** Only candidates of contested rural area will be allocated with designated spots. The number and size of designated spots for allocation to the contested candidates will be finalized by the RO, taking into account the number of candidates in the relevant rural area, after the close of nominations. Designated spots will be allocated by agreement of the representatives of all candidates contesting in the same rural area or by the drawing of lots.)
