填寫候選人退選通知書說明

Notes on Completion of Notice of Withdrawal of Candidature

- 獲提名而欲退出選舉的候選人，必須填寫本通知書。此通知書須由候選人於見證人在場下簽署。任何年滿 18 歲並持有身分證明文件的人士，均可擔任見證人。根據《鄉郊代表選舉條例》(第 576 章) 第 2(1)條，“身分證明文件”(identity document) 指—
This notice must be completed by a nominated candidate who wishes to withdraw his/her candidature. This notice must be signed by the candidate in the presence of a witness who can be any person aged 18 years or over and in possession of an identity document. According to section 2(1) of the Rural Representative Election Ordinance (Cap. 576), “identity document” (身分證明文件) means—
 - 身分證；或
an identity card; or
 - 向某人發出而可獲選舉登記主任接受為該人的身分證明的任何其他文件。
any other document issued to a person that is acceptable to the Electoral Registration Officer as proof of the person’s identity.

The witness is required to complete and sign PART II of this notice.
- 根據《選舉程序(鄉郊代表選舉)規例》(第 541L 章) 第 14 條，候選人須在提名期結束前藉向選舉主任交付退選通知書而退選。填妥的通知書須於提名期結束前(即 2025 年 3 月 31 日或之前)在通常辦公時間內由候選人或候選人的選舉代理人親自交付予有關的選舉主任。在該日期後，將不接受退選。選舉主任辦事處的地址已刊登在憲報內。
In accordance with section 14 of the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541L), a withdrawal of candidature is effected by delivering a notice of withdrawal to the Returning Officer before the close of nomination. The duly completed notice must be delivered to the relevant Returning Officer by the candidate or the candidate’s election agent in person during ordinary business hours **before the close of nominations (i.e. on or before 31 March 2025)**. **Withdrawal will not be accepted after that date.** The address of the office of the Returning Officer has been specified in the Gazette.
