Notes on Completion of Notification of the Electronic Address of the Candidate's Platform

1. 為符合《選舉程序(鄉郊代表選舉)規例》(第 541L 章)第 92(2)條與選舉廣告有關的公眾查閱規定,"候選人平台"是指由候選人或獲其授權的人士所維持以供候選人在發布選舉廣告後的3個工作天(即公眾假期及星期六以外的任何一天)內上載選舉廣告詳情予公眾查閱的公開平台。

To comply with the public inspection requirement governing election advertisements under section 92(2) of Electoral Procedure (Rural Representative Election) Regulation (Cap 541L), the "Candidate's Platform" refers to an open platform maintained by the candidate/a person authorized by the candidate which allows the candidate to post election advertisement particulars, within 3 working days (i.e. any day other than a general holiday and Saturday) after the publication of an election advertisement for public inspection.

In establishing a Candidate's Platform, the candidate must ensure that the platform complies with the rules and requirements as set out in section 92 of the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541L), and Chapter 7 and Appendix 4 of the "Guidelines on Election-related Activities in respect of the Rural Representative Election". A proposed layout design of Candidate's Platform is attached for ease of reference (see Annex).

A candidate must ensure his/her Candidate's Platform continues to operate until the end of the period for which copies of election returns are available for public inspection pursuant to section 41 of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554) to facilitate public inspection of the election advertisements.
