  - (a) 任何星期一、星期二、星期三、星期四或星期五(公眾假期除外)上午 9 時至下午 5 時; 及
  - (b) 在符合以下說明的期間內,星期六(公眾假期除外)上午9時至中午12時 ——
    - (i) 由根據第 4(1)或 6條就某項選舉刊登公告的日期起;而
    - (ii) 至根據《鄉郊代表選舉條例》(第 541L 章)刊登該項選舉的結果的日期,或根據該條例宣布該項選舉未能完成或終止的日期(兩個日期以較後者為準)為止。
- 1) Under section 2 of Electoral Procedure (Rural Representative Election) Regulation (Cap. 541L), ordinary business hours means the hours—
  - (a) between 9 a.m. and 5 p.m. on any Monday, Tuesday, Wednesday, Thursday or Friday (other than a general holiday); and
  - (b) between 9 a.m. and 12 noon on a Saturday (other than a general holiday) during the period between—
    - (i) the date of publication of a notice under section 4(1) or 6 in respect of an election; and
    - (ii) the date of publication of the result of the election under the Rural Representative Election Ordinance (Cap. 541L) or the date of the declaration of the failure or termination of the election under that Ordinance, whichever is the later.
