使用印本形式呈交選舉廣告作公眾查閱須知 Notes on Submission of Election Advertisements in Hard Copies for Public Inspection

為符合在現行的選舉條例及指引下有關公眾查閱的要求,候選人須以民政事務總署指明的方式及時間內,即於**發布選舉廣告後的三個工作天內**,向選舉主任繳存**有關選舉廣告印本及有關的資料/文件(包括准許/授權或支持同意書)**,或上載選舉廣告的電子文本到由民政事務總署署長所維持的公開平台(即「中央平台」)或由候選人所維持的公開平台(即「候選人平台」),供公眾查閱。如候選人選擇以印本形式向有關選舉主任呈交選舉廣告作公眾查閱,請細閱《鄉郊代表選舉活動指引》第七章及參考以下常見例子。候選人可於鄉郊代表選舉網站(https://www.had.gov.hk/rre)下載最新版本的「選舉廣告資料摘要」(「資料摘要」)(HAD/C10/By-E)及「修正選舉廣告資料摘要通知書」(「修正通知書」)(HAD/C11/By-E)。

Under the current electoral legislation and guidelines, to comply with the public inspection requirement, a candidate may deposit hard copies of their Election Advertisements ("EAs") and the relevant information/documents (including permission/authorization or consent of support), with Returning Officers ("ROs"), or post the electronic copies onto an open platform maintained by the Director of Home Affairs (referred to as "Central Platform") or an open platform maintained by the candidate (referred to as "Candidate's Platform") for public inspection in the manner and time specified by the Home Affairs Department (i.e. within 3 working days after the publication of the EAs). If the candidate chooses to submit hard copies of the EAs to the relevant RO for public inspection, he/she should read Chapter 7 of the "Guidelines on Election-related Activities in respect of the Rural Representative Election" and make reference to the following common examples. The candidate may download the latest version of the "Information Sheet in relation to Election Advertisements" ("Notification of Correction") (HAD/C10/By-E) and "Notification of Corrected Information in relation to Election Advertisements" ("Notification of Correction") (HAD/C11/By-E) at the Rural Representative Election website (https://www.had.gov.hk/rre).

事例 (一) Case 1

候選人於 11月9日共印刷 3,000 張傳單,並在 11月10日(假設11月10日為星期日及11月11日至13日為工作天)於街頭派發其中 1,000 張傳單。

候選人須於 11月13日或之前(即首次發布該選舉廣告日期後的三個工作天內)向選舉主任遞交資料摘要以提供選舉廣告詳情,並同時繳存兩份有關選舉廣告的樣本,供公眾查閱。有關資料摘要應以**例 1.1** 的方式填寫。

A candidate printed 3,000 copies of handbills in total on 9 November, and distributed 1,000 copies of the handbills on the streets on 10 November (assuming 10 November is a Sunday and 11 to 13 November are working days).

The candidate is required to provide the EA particulars by submitting the Information Sheet and 2 hard copies of the EA sample to the RO for public inspection on or before 13 November (i.e. within 3 working days after the date on which the EA is first published). The Information Sheet should be filled in as shown in **Example 1.1**.

若候選人於 11 月 11 日於街頭再派發餘下的 2,000 張傳單,候選人須於 11 月 14 日或之前(即首次發布該選舉廣告日期後的三個工作天內)向選舉主任遞交資料摘要以提供選舉廣告詳情,並同時繳存兩份有關選舉廣告的樣本,供公眾查閱。有關資料摘要應以**例 1.2** 的方式填寫。

If a candidate distributed the remaining 2,000 copies of the handbills on the streets on 11 November, the candidate is required to provide the EA particulars by submitting the Information Sheet and 2 hard copies of the EA sample to the RO for public inspection on or before 14 November (i.e. within 3 working days after the date on which the EA is first published). The Information Sheet should be filled in as shown in **Example 1.2**.

候選人須於 11月13日或之前向選舉主任遞交資料摘要,並同時繳存兩份有關選舉廣告的樣本及一份有關店舖預先發出的書面准許/授權文本,供公眾查閱。有關資料摘要應以**例 2.1** 的方式填寫。

A candidate printed 3,000 copies of posters in total on 9 November, and displayed a poster each at 20 shops on 10 November (assuming 10 November is a Sunday and 11 to 13 November are working days).

The candidate is required to submit the Information Sheet together with 2 hard copies of the EA sample and a copy of the prior written permission/authorization issued by the relevant shops to the RO for public inspection by 13 November. The Information Sheet should be filled in as shown in **Example 2.1**.

候選人於 11月10日自製一份電子版的海報,並將有關電子海報透過以下的電子方式發布。候選人在填寫資料摘要時可參考以下例子: A candidate created an electronic copy of a poster on 10 November and published it via the following electronic means. The candidate may make reference to the following examples when completing the Information Sheet –

- (1) 如候選人將電子海報在同日於<u>一個</u>或<u>多於一個</u>的社交媒體發布(例如:Facebook、Instagram等),他/她可向選舉主任遞交資料摘要,在「發布的方式」一欄列出有關社交媒體名稱,並同時繳存該選舉廣告一式兩份全彩色相片/打印本/影印本,供公眾查閱(請參考例 3.1 項目編號 1)。但是,若候選人於同日另以電郵及 WhatsApp 等形式將該電子海報傳送給100 位支持者,由於發布的方式不同,應被視為發布新的選舉廣告,該候選人須另行填寫選舉廣告詳情,並同時繳存該選舉廣告一式兩份全彩色相片/打印本/影印本,供公眾查閱(請參考例 3.1 項目編號 2)。
- (1) If the candidate published the electronic poster via <u>one</u> or <u>more than one</u> social media on the same date (e.g. Facebook, Instagram, etc.), he/she may submit to the RO the Information Sheet setting out the name(s) of the social media concerned under the "Manner of publication", together with 2 identical full colour photographs/printouts/photocopies of the EA for public inspection (please refer to **Item 1 of Example 3.1**). However, if the candidate also sent the electronic poster to 100 supporter(s) via electronic mail and WhatsApp etc. on the same date, it should be regarded as publishing a new EA as the poster was published in a different manner. As such, that candidate is required to fill the EA particulars in a separate row with 2 identical full colour photographs/printouts/photocopies of the EA submitted to the RO for public inspection (please refer to **Item 2 of Example 3.1**).
- (2) 如候選人將電子海報在<u>不同</u>日期於<u>不同</u>的社交媒體發布(例如:在 11月 10 日於 Facebook 發布,在 11月 11 日於 Instagram發布),候選 人可參照以**下例 3.2** 的方式填寫選舉廣告詳情,並同時繳存該選舉廣告一式兩份全彩色相片/打印本/影印本,供公眾查閱。
- (2) If the candidate published the electronic poster on <u>different</u> dates on <u>different</u> social media (e.g. published on Facebook on 10 November and on Instagram on 11 November), the candidate may fill in the EA particulars as shown in **Example 3.2** below and submit at the same time 2 identical full colour photographs/printouts/photocopies of the EA to the RO for public inspection.

候選人於 11月9日共印刷 3,000 張傳單,並於 11月10日在街頭派發有關傳單。候選人已於 11月 11 日向選舉主任遞交資料摘要及有關傳單的樣本供公眾查閱。惟候撰人其後發現派發的傳單數量應為 2,000 張,而非先前填寫的 3,000 張。

在此情況下,候選人須最遲於投票日後三個工作天內向選舉主任繳存修正通知書,以修改該選舉廣告的詳情。候選人須在修正通知書中的**第1頁第1段**列明上述資料摘要**遞交的日期**,以便選舉主任對照有關選舉廣告。候選人只須填寫須修改的項目,而無須重新填寫其他並不需要修改的項目。有關修正通知書應以**例4.1**的方式填寫。

A candidate printed 3,000 copies of handbills in total on 9 November and distributed them on the streets on 10 November. The candidate submitted the Information Sheet together with the samples of the handbills to RO on 11 November for public inspection. However, the candidate later found that the number of handbills distributed should be 2,000 instead of 3,000.

In this case, the candidate has to correct such EA particulars by submitting the Notification of Correction to the RO not later than 3 working days after the polling day. The candidate should state the date of submission of the aforesaid Information Sheet in paragraph 1 of page 1 of the Notification of Correction for RO's reference. The candidate should only fill in the information to be corrected and does not need to fill in other items which no correction is required. The relevant Notification of Correction should be filled in as shown in **Example 4.1**.

在此情況下,候選人須最遲於投票日後三個工作天內向選舉主任遞交修正通知書以修改該選舉廣告詳情,並重新向選舉主任繳存兩份正確的選舉廣告樣本。候選人須在修正通知書中的**第1頁第1段**列明上述資料摘要**遞交的日期**,以便選舉主任對照有關選舉廣告。有關修正通知書應以**例 5.1** 的方式填寫。

A candidate printed 3,000 copies of handbills in total on 9 November and distributed them on 10 November. The candidate submitted the Information Sheet together with the EA samples to the RO for public inspection on 11 November. However, the candidate later found that he/she had wrongly deposited with the RO the samples of another handbill.

In this case, the candidate has to correct the EA particulars by submitting a Notification of Correction together with 2 correct EA samples to the RO not later than 3 working days after the polling day. The candidate is required to state **the date of submission** of the aforesaid Information Sheet in **paragraph 1** of **page 1** of the Notification of Correction for RO's reference. The relevant Notification of Correction should be filled in as shown in **Example 5.1**.

在此情况下,

(1) 候選人須先向選舉主任遞交修正通知書以修改於 11 月 10 日派發的選舉廣告的詳情,將街頭派發的傳單數目由 1,000 改為 500。有關修正通知書 應以**例 6.1** 的方式填寫。

A candidate printed 3,000 copies of handbills in total on 9 November and distributed 1,000 copies of the handbills on the streets on 10 November. The candidate submitted the Information Sheet and EA samples to RO on 11 November. However, the candidate later stated that the number of handbills distributed on the streets on 10 November should be 500 instead, and the remaining 500 were distributed on 12 November by post.

In this case,

(1) the candidate is required to first correct the EA particulars distributed on 10 November by submitting the Notification of Correction to the RO to change the number of handbills distributed on the streets from 1,000 to 500. The Notification of Correction should be filled in as shown in **Example 6.1**.

- (2) Regarding the remaining 500 handbills that were distributed by post on 12 November, they should be regarded as publishing a new EA as the handbills were distributed in a different manner. Instead of further correcting the particulars of the submitted EAs, the candidate is required, in respect of such handbills that were distributed by post, to submit a new Information Sheet together with 2 copies of the relevant EA sample to the RO on or before 15 November. The Information Sheet should be filled in as shown in **Example 6.2**.

事例(八) Case 8

候選人於 11月 9日製作 10 張只有其姓名及圖像的橫額,並於 11月 10日在街頭展示。候選人於 11月11 日已向選舉主任遞交資料摘要及繳存該選舉廣告一式兩份全彩色相片。候選人其後於 11月 12日於該橫額貼上新標語。

由於新舊橫額所顯示的內容不同,被貼上新標語的橫額應被視為一個新的選舉廣告。因此候選人須於11月 15 日或之前向選舉主任遞交一份新的資料 摘要,並繳存有關新的選舉廣告一式兩份全彩色相片,而不是修正之前發布的選舉廣告詳情。有關資料摘要應以**例 8.1** 的方式填寫。

A candidate produced 10 banners only with his/her name and image on 9 November, and displayed them on the street on 10 November. The candidate submitted the Information Sheet together with 2 identical full colour photographs of the EA to RO by 11 November. The candidate later stuck new slogans on those banners on 12 November.

As the content on the previous and new banners are different, the banners with new slogans should be regarded as new EAs. The candidate is required, instead of correcting the EA particulars submitted previously, to submit a new Information Sheet together with 2 identical full colour photographs of the new EA to the RO on or before 16 November. The Information Sheet should be filled in as shown in **Example 8.1**.
