Please note the following with regard to the personal data supplied in connection with this notice-

**(a) Purpose of Collection**

The personal data and other related information supplied in connection with this notice will be used by the Electoral Affairs Commission, the Home Affairs Department, the Returning Officer for the relevant rural area, other related government departments and agencies for election-related purposes.

**(b) Access to Personal Data**

A person has the right to request access to and correction of the personal data he/she supplied in this notice in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).

**(c) Enquiry**
