display or wear any badge, emblem, clothing or head-dress which may promote or prejudice the election of a candidate or candidates at the by-election;

display or wear any badge, emblem, clothing or head-dress which makes direct reference to a political body in Hong Kong or a body any member of which is standing as a candidate in the by-election;

- (h) 索問或查閱選民的身分證明文件。 seek to check or check any elector's identity document.

\*I/Each of us further understand(s) that \*I/we must not —

(a) 藉傳達關於選民登記冊上的資料如選民身分證明文件號碼或姓名,或藉其他方式,向他 人透露某人是否已申領選票或已於專用投票站投票; divulge to any other person by communicating information such as the identity document

number or name of an elector in the register of electors, or otherwise, as to whether a person has or has not applied for a ballot paper or voted at the dedicated polling station;

- (b) 向他人透露某受羈押選民的身分; divulge to any other person the identity of an elector in custody;
- (c) 向他人傳達在專用投票站內取得的關於在該專用投票站的選民將會投票或已投票予哪位 候選人的資料;或 communicate to any person any information obtained in the dedicated polling station as to the candidate for whom an elector in that dedicated polling station is about to vote or has voted; or

Notes on Completion of Notice of Appointment of Polling Agent for a Dedicated Polling Station Situated in a Prison (other than a Maximum Security Prison) and Application for Consent to the Presence of Election Agent/Polling Agent in a Dedicated Polling Station Situated in a Prison (other than a Maximum Security Prison)

(1) 除非候選人以指明表格明文另作示明,有關代理人須當作是為在預定日期進行的投票和(如適用的話) 於遭押後或延遲的該次投票而委任。

The agent is to be regarded as being appointed for the poll to be conducted on the scheduled date and (where applicable) the postponed or adjourned poll, unless the candidate expressly indicates otherwise in the specified form.

- (2) 每名候選人只可以為其選舉代理人或其一位監察投票代理人申請在某個位於監獄內的專用投票站內 停留。選舉代理人或監察投票代理人不可在位於高度設防監獄內的專用投票站停留。

The requirements for applying for the presence of election agent and polling agent in a dedicated polling station situated in a prison are stated in sections 22, 36 and 37 of the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541L), an extract of which is reproduced below for reference -

(3) 候選人可根據本規例或須根據本規例在與選舉相關的情況下作出的所有事情,均可由他委任的 選舉代理人作出,但下述事情除外—

An election agent appointed by a candidate may do all things which the candidate may do or is required to do under this Regulation in connection with an election except-

- (a) 作出第7(1)(b)條或《選舉條例》第24條提述的聲明; making a declaration referred to in section 24 of the Election Ordinance or section 7(1)(b);
- (b) 以獲提名的候選人身分在提名表格上簽署; signing a nomination form as the candidate being nominated;
- (c) 以候選人身分在第14(2)條提述的退選通知書上簽署;
  - signing a notice of withdrawal of candidature referred to in section 14(2) as the candidate;
- (d) 根據第(1)款委任選舉代理人;
  - appointing an election agent under subsection (1);
- (e) 根據第23條委任選舉開支代理人;
  - appointing an election expense agent under section 23;
- (f) 代候選人招致選舉開支,但如他亦獲候選人根據第23條委任為該候選人的選舉開支代理人,則屬例外;
  - incurring election expenses on behalf of the candidate, unless he has also been appointed by the candidate as the candidate's election expense agent under section 23;
- (g) 根據第24(4)條撤銷選舉代理人或選舉開支代理人的委任;
  - revoking the appointment of an election agent or election expense agent under section 24(4);
- (h) 在(i)段的規限下,在位於監獄內的專用投票站內停留,但如懲教署署長應在投票日前一星期之前藉專人送遞、郵遞、電子郵件或圖文傳真方式交付予選舉主任的符合指明格式的申請,同意讓該人在該等投票站內停留,則屬例外;或
  - subject to paragraph (i), being present in a dedicated polling station situated in a prison unless, upon an application in the specified form delivered by hand, by post, by electronic mail or by facsimile transmission to the Returning Officer at least one week before polling day, the

Commissioner of Correctional Services consents to his presence; and

(i) 在位於高度設防監獄內的專用投票站內停留。

being present in a dedicated polling station situated in a maximum security prison.

(3A) 如懲教署署長已根據第37(1A)條,向同一名候選人的監察投票代理人給予同意,則他不得根據第(3)(h)款給予同意。

The Commissioner of Correctional Services must not give consent under subsection (3)(h) if he has given consent under section 37(1A) to a polling agent of the same candidate.

(3B) 儘管有第(3)(h)款的規定,如懲教署署長信納—

Despite subsection (3)(h), the Commissioner of Correctional Services may, upon an application made under that subsection during the week before polling day, give consent under that subsection if he is satisfied that-

(a) 在投票日前一星期內,有某名有權在位於監獄內的專用投票站投票的受羈押選民被收入 或轉往該監獄;及

an elector in custody who is entitled to vote at a dedicated polling station situated in a prison is admitted or transferred to the prison during that week; and

(b) 在該名選民被如此收入或轉往該監獄後,有關申請在沒有無故拖延的情況下,在該星期 內根據該款交付,

the application is made without undue delay after the admission or transfer.

(3C) 如懲教署署長拒絕根據第(3)(h)款給予同意,則他必須在切實可行的範圍內,盡快通知有關 候撰人或撰舉代理人。

If the Commissioner of Correctional Services refuses to give consent under subsection (3)(h), he must notify the candidate or the election agent as soon as practicable.

# 監察投票代理人的委任〔《選舉程序(鄉郊代表選舉)規例》(第541L章)第36條〕

Appointment of polling agent (Section 36 of the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541L)

(1A) 儘管有第(1)款的規定,及除第37(1A)、(1B)及(6B)條另有規定外,每名候選人只可就每個位於監獄內的專用投票站,委任一名監察投票代理人。

Despite subsection (1) and subject to section 37(1A), (1B) and (6B), only one polling agent may be appointed by a candidate for a dedicated polling station situated in a prison.

## 進入投票站 [《選舉程序(鄉郊代表選舉)規例》(第541L章)第37條]

Admission to polling station [(Section 37 of the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541L)]

(1A) 監察投票代理人不得在位於監獄內的專用投票站內停留,但在以下情況下除外—

A polling agent may not be present in a dedicated polling station situated in a prison unless-

- (a) 在投票日前的第7天或之前,有委任通知發出,並藉專人送遞、郵遞、電子郵件或圖文傳真方式,交付予民政事務總署署長;及
  - a notice of appointment is given at least 7 days before polling day and delivered to the Director of Home Affairs by hand, by post, by electronic mail or by facsimile transmission; and
- (b) 懲教署署長同意該項委任。

the Commissioner of Correctional Services consents to the appointment.

(1B) 如懲教署署長已根據第22(3)(h)條,向同一名候選人的選舉代理人給予同意,則他不得根據 第(1A)款給予同意。

The Commissioner of Correctional Services must not give consent under subsection (1A) if he has given consent under section 22(3)(h) to the election agent of the same candidate.

(1C) 儘管有第(1A)款的規定,如懲教署署長信納—

Despite subsection (1A), even though a notice of appointment is given during the week before polling day, the Commissioner of Correctional Services may still give consent under that subsection if the Commissioner is satisfied that-

- (a) 在投票日前一星期內,有某名有權在位於監獄內的專用投票站投票的受羈押選民被收入 或轉往該監獄;及
  - an elector in custody who is entitled to vote at a dedicated polling station situated in a prison is admitted or transferred to the prison during that week; and
- (b) 在該名選民被如此收入或轉往該監獄後,有關委任通知在沒有無故拖延的情況下發出, the notice of appointment is given without undue delay after the admission or transfer.

則雖然該通知是在該星期內發出的,署長仍可根據該款給予同意。

(1D) 如懲教署署長拒絕根據第(1A)款給予同意,則署長必須在切實可行的範圍內,盡快通知有關 候選人或其選舉代理人。

If the Commissioner of Correctional Services refuses to give consent under subsection (1A), the Commissioner must notify the candidate or the election agent of the candidate as soon as practicable.

(2) 投票站主任為確保投票得以順利及有效率地進行—

In order to ensure that polling takes place smoothly and efficiently, the Presiding Officer-

- (a) 可規限在同一時間獲准進入有關投票站的選民、候選人、選舉代理人及監察投票代理人 的人數;及
  - may regulate the number of electors, candidates, election agents and polling agents to be admitted to the polling station concerned at any one time; and
- (b) 可禁止任何人(第(1)款另有規定者除外)置身於有關投票站內。 may, subject to subsection (1), exclude any person from the polling station concerned.
- (3) 候選人、選舉代理人或監察投票代理人在投票站內指定容納他們的範圍內仍有空座位的情況下,才可在該投票站內停留。
  - A candidate, an election agent or a polling agent may be present in a polling station subject to the availability of seats in the area designated to accommodate them.
- (4) 選舉代理人或監察投票代理人在關乎其委任的通知已根據本規例發出後,始可代有關候選人 在投票站內停留。
  - Only an election agent or a polling agent regarding whom a notice of appointment has been given under this Regulation may be present in a polling station on behalf of a candidate.
- (5) 如某候選人正在投票站內停留,則該候選人的選舉代理人不得在同一時間在該投票站內停留。
  - If a candidate is present in a polling station, the election agent of that candidate may not be present in the polling station at the same time.
- (6) 如某候選人及其選舉代理人均沒有在投票站內停留,則在同一時間只可有一名監察投票代理 人代該候選人在該投票站內停留。
  - Only one polling agent of a candidate may be present in a polling station, on behalf of the candidate, at any one time, if neither the candidate nor the election agent is present.
- (6B) 任何選舉代理人或監察投票代理人均不得在位於高度設防監獄內的專用投票站內停留。
  No election agent or polling agent may be present in a dedicated polling station situated in a maximum security prison.
- (4) 凡年滿18歲的香港身分證持有人均可被委任為監察投票代理人。任何人可被委任為多於一個投票站的 監察投票代理人。候選人或其選舉代理人不應委任任何選舉主任、助理選舉主任、或任何已受選舉主任或民政事務總署署長委任協助進行投票或點票的人士(通常為政府公職人員)為其監察投票代理人。 Any person who is a holder of a Hong Kong Identity Card and has attained the age of 18 years may be appointed as a polling agent. A person can be appointed as a polling agent for more than one polling station. A candidate or his/her election agent should not appoint any Returning Officer, Assistant Returning Officer, or any person (usually a government officer) already appointed by the Returning Officer or the Director of Home Affairs to assist at the poll or the count as his/her polling agent.
- (5) (a) 就每名候選人而言,在候選人、其選舉代理人或其監察投票代理人中,同一時間內只限**一人**進入 及停留在一個投票站內監察投票。

For each candidate, only **one** among the candidate, his/her election agent or his/her polling agent may be present in a polling station to observe the poll at any one time.

- (b) 投票站主任可以規限可進入投票站的候選人、選舉代理人或監察投票代理人的數目。如可容納該 等人士的指定範圍已滿座,投票站主任可拒絕其他該等人士在該等時間進入投票站。
  - The admission into the polling station of a candidate, his/her election agent or polling agent is subject to the overriding power of the Presiding Officer to regulate the number of persons admitted to the polling station. If full capacity of the area inside the polling station designated for such persons has been reached, the Presiding Officer may refuse further admission.
- (c) 進入投票站的指定範圍監察投票一般採用先到先得的方法。假若在同一時間內要求進入指定範圍的人數超額,將以抽籤決定進入的先後次序。
  - Admission to the designated area of the polling station to observe the poll will normally be on a first-come-first-served basis. If the number of persons seeking admission at the same time exceeds the capacity, then lots will be drawn to determine the priority of entry.
- (d) 獲准進入指定範圍的人士,只可在指定範圍內逗留一小時;除非其後在指定範圍內的人數並未滿額,亦無其他人士在輪候進入該範圍,否則他/她必須離開。每位進入投票站的人士須在投票站職員保管的記錄表簽到並記錄進入時間。
  - A person will only be allowed to stay in the designated area for <u>ONE HOUR</u>, thereafter he/she must leave unless the designated area is not fully occupied and no other person is waiting to be admitted. Every person admitted to the polling station is required to sign in and enter the time of admission on the log sheet kept by the polling staff.

  - When the designated area is full, each person waiting to be admitted will be issued a number chit in sequence to record the order of his/her entry to the designated area when a vacant seat arises. When it is his/her turn, his/her number will be called outside the entrance to the polling station, but if he/she is not present, then admission will be granted to the one holding the next number chit. Such an absentee will have to obtain another number chit and join the queue afresh on his/her return.

  - The notice/application must be delivered to the Director of Home Affairs via the Returning Officer for the relevant rural area by hand, by post, by electronic mail or by facsimile transmission at least 7 days before the polling day (i.e. on or before 13 May 2018).

  - The applicant will receive an acknowledgement receipt from the Returning Officer after submission of this notice/application. You may use the application number as stated in the acknowledgment receipt to check the application result in the Rural Representative Election website "www.had.gov.hk/rre". The applicant will only be notified if the Commissioner of Correctional Services refuses to give consent to the agent(s) to enter the dedicated polling station.
