(附註：根據《鄉郊代表選舉活動指引》第四章，候選人必須在提名期內以書面形式向有關鄉郊地區的選舉主任表明是否有意在指定展示位置展示選舉廣告。指定展示位置只會編配給需競逐的候選人。選舉主任會在提名期結束後根據有關鄉郊地區內需競逐的候選人數目，來決定可供編配給候選人的指定展示位置的數目及尺寸，並會以協議或抽籤方式，把指定展示位置編配予各競逐的候選人。

(Note: According to Chapter 4 of “Guidelines on Election-related Activities in respect of the Rural Representative Election”, candidates **must inform the Returning Officer (“RO”) for the relevant rural area of their intention to display election advertisements at designated spots in writing within the nomination period.** Only contesting candidates will be allocated with designated spots. The number and size of designated spots for allocation will be finalised by the RO, taking into account the number of contesting candidates in the respective rural area, after the close of nominations. The RO will allocate the designated spots to the contesting candidates either in accordance with the mutual consent of the contesting candidates or by the drawing of lots.

### Notes on Personal Data Supplied in connection with this Intention

(a) **資料用途**

就此意願書提供的個人及其他有關的資料，會供選舉管理委員會、民政事務總署、有關鄉郊地區的選舉主任及其他有關的政府部門和機構用於與選舉有關的用途。

**Purpose of Collection**

The personal data and other related information supplied in connection with this intention will be used by the Electoral Affairs Commission, the Home Affairs Department, the Returning Officer for the relevant rural area, other related government departments and agencies for election-related purposes.

(b) **索閱個人資料**

**Access to Personal Data**

A person has the right to request access to and correction of the personal data he/she supplied in this intention in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap.486).
