## 填寫接受選舉捐贈預先申報書及聲明書說明

### Notes on Completion of Advance Return and Declaration of Election Donations

1. 在填寫此申報書及聲明書前，請閱讀《選舉（舞弊及非法行為）條例》（第 554 章）及選舉管理委員會發出的《鄉郊代表選舉活動指引》第十二章。  
Please read the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554) and Chapter 12 of the “Guidelines on Election-related Activities in respect of the Rural Representative Election” issued by the Electoral Affairs Commission before completing this return and declaration.
2. 選舉捐贈的形式包括金錢、貨品及服務。不論形式為何，所有已接受的選舉捐贈，均須在此申報書及聲明書的相關部分填報。  
Election donations may take the form of money, goods or service. Regardless of the form they take, all election donations received must be accounted for under the relevant sections in this return and declaration.
3. 根據《選舉（舞弊及非法行為）條例》（第 554 章）第 2(1)條，“選舉捐贈”（election donation）就某項選舉的一名或多於一名候選人而言，指以下任何捐贈—

  - (a) any money given to or in respect of the candidate for the purpose of meeting, or contributing towards meeting, the election expenses of the candidate;
  - (b) any goods given to or in respect of the candidate for the purpose of promoting the election of the candidate or of prejudicing the election of another candidate or other candidates, and includes any goods given incidental to the provision of voluntary service;
  - (c) any service provided to or in respect of the candidate for the purpose of promoting the election of the candidate or of prejudicing the election of another candidate or other candidates, but does not include voluntary service.

(b) **資料轉介**

**Transfer of Information**

A copy of this return and declaration and all attachments will be made available for public inspection until the end of the period for which copies of election returns are available for inspection under section 41 of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554). All personal data (if any, except the address of the donor) in the return and declaration and all attachments will be covered before display. The personal data and other related information supplied in connection with this return and declaration may be provided to other authorised departments/organisations/persons including but not limited to the law courts for election-related purposes.

(c) **索閱個人資料**

**Access to Personal Data**

A person has the right to request access to and correction of the personal data he/she supplied in this return and declaration in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).

(d) **個人資料保障原則**
