A witness can be any person aged 18 years or over and in possession of an identity document. According to section 2(1) of the Rural Representative Election Ordinance (Cap. 576), "identity document" (身分證明文件) means –

- (a) 身分證;或 an identity card; or
- (b) 向某人發出而可獲選舉登記主任接受為該人的身分證明的任何其他文件。 any other document issued to a person that is acceptable to the Electoral Registration Officer as proof of the person's identity.
- 5. 根據《鄉郊代表選舉活動指引》第四章及《選舉程序(鄉郊代表選舉)規例》(第 541L 章)第 92 條,候選人須在發布選舉廣告後的一個工作天(即公眾假期及星期六以外的任何一天)內,把與選舉廣告有關的資料/文件,包括准許或同意書的電子文件,上載至中央平台或候選人平台或向選舉主任繳存印本式文本,以供公眾查閱。

In accordance with Chapter 4 of the "Guidelines on Election-related Activities in respect of the Rural Representative Election" and section 92 of the Electoral Procedure (Rural Representative Election) Regulation (Cap. 541L), the candidate must, within 1 working day (i.e. any day other than a general holiday and Saturday) after publication of an election advertisement, post an electronic copy of the relevant information/document, including permission or consent, onto the Central Platform or Candidate's Platform or deposit a hard copy with the Returning Officer for public inspection.

(a) 資料用途

Purpose of Collection

The personal data and other related information supplied in connection with this notification will be used by the Electoral Affairs Commission, the Home Affairs Department, the Returning Officer for the relevant rural area and other related government departments for election-related purposes.

(b) 資料轉介

此通知書會供公眾查閱直至選舉申報書的文本根據《選舉(舞弊及非法行為)條例》(第554章) 第41條可供查閱的期間結束為止。在展示前,通知書內所有電話號碼將會被遮蓋。就此通知書提 供的個人及其他有關的資料亦可能會提供予其他獲授權的部門/機構/人士,包括但不限於法院, 用於與選舉有關的用途。

Transfer of Information

This notification will be made available for public inspection until the end of the period for which copies of election returns are available for inspection pursuant to section 41 of the Elections (Corrupt and Illegal Conduct) Ordinance (Cap. 554). All telephone numbers in the notification will be covered before display. The personal data and other related information supplied in connection with this notification may also be provided to other authorised departments/organisations/persons including but not limited to the law courts for election-related purposes.

(c) 索閱個人資料

Access to Personal Data

A person has the right to request access to and correction of the personal data he/she supplied in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).
