- ➤ directly or indirectly use the information / results of the exit poll for electioneering purpose in promoting or prejudicing the election of candidate(s).

("EAC"), especially Chapter 14, including (but not limited to) the following requirements to be observed by those persons listed in Attachment I -

- As specified in paragraph 14.3 of the Guidelines, exit polls **must** be conducted within the No Canvassing Zone ("Designated Area") outside the exit of the polling station;
- not to use any communication or photographic devices;
- display prominently the identification device issued by the HAD when conducting the exit poll;
- respect the electors' right and wish not to be disturbed;
- prior to conduct of exit poll, use the "Standard Script for Interviewers Conducting Exit Poll" provided by the HAD to inform the electors being interviewed that their participation in the exit poll is entirely voluntary;
- at the start of the interview, make known to the electors the name of the person or organisation conducting the exit poll and that the exit poll is not commissioned by the Government;
- not to collect or retain any personal data relating to the identity of the electors (i.e. any data relating directly or indirectly to the electors, from which it is practicable for their identities to be directly or indirectly ascertained, such as names, Hong Kong Identity Card numbers, telephone numbers and addresses);
- > not to stay, loiter or accost electors in the areas designated as the No Staying Zone;
- when conducting the exit poll, should keep a reasonable distance from the exit of the polling station(s) to ensure that electors entering the polling station(s) will not be affected;
- > not to speak to or otherwise communicate with candidates or their agents when conducting the exit poll outside polling station(s); and
- > not to canvass electors in the No Canvassing Zone or carry out any activities that will give rise to suspicion that they are canvassing electors inside the No Canvassing Zone (please refer to Chapter 14 of the Guidelines).

 - I understand that, if * I or any person conducting the exit poll / I, the Applicant Organisation or any person conducting the exit poll fail(s) to comply with the rules in the Guidelines governing the conduct of exit poll or the matters stated in paragraphs 4 to 9 of this PART, the HAD may revoke the approval to conduct an exit poll on the polling day or during the polling hours forthwith without prior warning. The EAC may also make a reprimand or censure in a public statement which will include the name of the person or organisation who / which fails to comply with this declaration or the Guidelines and may take legal action against such person or organisation (including referral to the relevant law enforcement agencies).

Guidance Notes on Completion of Application Form

- 1. 在填寫此申請表前,請細心閱讀《鄉郊代表選舉活動指引》及相關補充資料(如有的話)。 Please read carefully the Guidelines on Election-related Activities in respect of the Rural Representative Election and relevant supplementary information (if any) before completing this Application Form.
- 2. 請用中文或英文填寫此申請表。
 Please complete this Application Form either in Chinese or in English.
- 3. 有意申請進行票站調查的**機構**,在決定由誰人作出法定聲明時,應考慮該人是否符合申請表第一部分第1段所述的要求。

Any <u>organisation</u> which intends to apply to conduct an exit poll, when deciding who is to make the statutory declaration, should consider whether such person satisfies the requirements stated in paragraph 1 of PART I of the Application Form.

To forestall public perception of unfairness and to maintain order at the polling stations, approval would normally not be granted in the following circumstances:

- (a) the applicant / applicant organisation has publicly expressed support for any candidate(s) contesting in the By-Election in the Rural Area covered by the exit poll(s);
- (b) the applicant organisation has member(s) contesting in the Rural Area covered by the exit poll(s) in the By-Election;
- (c) the person(s) responsible for the exit polls or interviewers deployed for the polls are currently members of any organisation(s):
 - (i) which have candidate(s) contesting in the Rural Area covered by the exit polls belong, or which have publicly expressed support for any candidate(s) contesting in the Rural Area covered by the exit polls in the By-Election;
 - (ii)which have publicly expressed support for any candidate(s) contesting in the By-Election;
- (d) the applicant / the applicant organisation, the person(s) responsible for the exit poll, or the conduct of the proposed exit polls may cause embarrassment to the EAC given its role; or/and
- (e) the proposed exit polls may cause disturbance or disorder at the polling station, compromise public perception of the credibility of the election, or lead to any public order or public health concerns, etc.

The <u>original</u> of the completed Application Form must be submitted in person or by post to the HAD **not** later than 10 days before the polling day (i.e. on or before 6:00 p.m. on 21 November 2024) (Address: 4th Floor, Southorn Centre, 130 Hennessy Road, Wan Chai, Hong Kong(Attention: Team 2, Division I, Home Affairs Department). Please state on the envelope "2024 Rural By-Election - Application Form for Conduct of Exit Poll".). If applicants / applicant organisations fail to provide accurate data as requested in this Application Form 10 days before the polling day, their applications to conduct an exit poll will not be processed.

(a) Purpose of Collection

The personal data and other information provided in this Application Form will be used by the EAC and the HAD for election-related purposes. A list of persons or organisations allowed to conduct exit poll, together with their contact telephone numbers will be released prior to the polling day for reference by the public and candidates. Such a list will also be displayed at each of the relevant polling stations respectively. All the identity document numbers and the declarants' addresses will be covered up before the lists are displayed.

(b) **Transfer of Information**

The personal data and other relevant information provided in this Application Form may also be provided to the relevant law enforcement agencies, other authorised departments or persons, including but not limited to the law courts for election-related purposes.

(c) Access to Personal Data

A person has the rights to request access to and correction of the personal data he / she provided in this Application Form in accordance with the provisions of the Personal Data (Privacy) Ordinance (Cap. 486).

(d) Personal Data Protection Principles

Applicants are reminded to observe the Data Protection Principles in Schedule 1 to the Personal Data (Privacy) Ordinance (Cap. 486) in collecting personal data of a third party in completing this Application Form, in particular Principle 4 concerning the requirement to take all practicable steps to ensure that personal data are protected against unauthorised or accidental access, processing, erasure, loss or use.
